TO THE QUALIFIED ELECTORS OF MACKINAC COUNTY:

PLEASE TAKE NOTICE that any qualified elector of Mackinac County who is not already registered, may register to vote at the office of the Township/City Clerk; the office of the County Clerk; a Secretary of State branch office, or other designated state agency. Registration forms can be obtained at mi.gov/vote and mailed to the Township/City Clerk. Voters who are already registered may update their registration at www.expressSOS.com.

The last day to register in any manner other than in-person with the local clerk is **Monday, July 20, 2026**.

After this date, anyone who qualifies as an elector may register to vote in person with proof of residency (MCL 168.492) at the following:
